Parents/guardians agree to letting us know if they are running late so we don't release the children before they have arrived. Full agreement is gained by the parents/guardians prior to booking on where to pick their children up from. Our terms specify no child should wait for their parents in any area

					other than the house or the gardens. This includes the upper and lower car parks. Under no circumstances must students exit the grounds to meet their parents/guardians.

No sets or steps are accessed without prior permission of the stage construction crew to ensure they are safe to use.
